Subject: **Notification of the Consulate of the Republic of Panama in Turkey, as Merchant Marine Privative Consulate.**

Reference: **Resolution J.D. No. 053-2012, Resolution No. 106-23-DGMM**

1. The purpose of this Circular is to inform users of the Panamanian Registry that our Administration, always committed to the continuous improvement, deemed necessary to provide consular services within the Republic of Turkey and has therefore, granted through Resolution J.D. No. 053-2012, the category of Merchant Marine Privative Consulate to the Consulate of the Republic of Panama in Turkey.
2. In this sense, the Consulate of the Republic of Panama in Turkey is authorized to receive and process applications for the provisional registration of ships, preliminary recording of title deeds, pre-cancellation notices and mortgages of vessels of the National Merchant Marine, as well as to collect taxes and rates related to the registration and operation of Panamanian foreign going ships. In addition, this Consulate has been authorized through Resolution J.D. No. 106-23-DGMM to carry out other functions related to the services performed by the International Offices of Segumar, such as the issuing of technical certificates.
