**Subject:** Maritime Labour Convention, 2006 (MLC, 2006) - Marine Casualties

**Reference:** Law 2 of January 6, 2009.

---

1. The purpose of this Circular is to inform users of the Panamanian registry that in accordance to the established by the Maritime Labour Convention, 2006, Regulation 5.1.6 about Maritime Accidents, any serious marine casualty taking place on board Panamanian flagged vessels, resulting into injuries or loss of life, shall be investigated by the Marine Accident Investigation Department.

2. That the investigation shall only be performed by personnel of the Marine Accident Investigation Department of the Panama Maritime Authority.
